2023 Membership Survey Results:

2 questions directly overlap with last year for the sake of direct comparison.

Keith: Transparency is a concern within the membership, sending out the raw results of the survey could help assuage concerns.

Regina: Doing so could hurt membership growth if members are exposed to negative opinions within the survey.

What is the intention of the survey:

Original purpose was to help the leadership move forward smoothly. Point out topics that club members are more or less interested in.

Nate R. points out that a summary of people's comments and ideas could be published instead of the whole block of raw info. Joanne backs this up, saying that doing so hides the "voice" of individual commenters and protects identities.

34 responders to the survey, though not all answered every question.

Keith and Chad drafted the questions

This year, so far, what direction do you think the club is moving?

2022: 29 responses:

55.2% positive direction 10.3% negative direction 34.5% no opinion

2023: 34 responses:

64.4% positive direction 11.8% negative direction 23.5% no opinion

This year so far, the meetings I've attended have been enjoyable:

2022:

72.4 enjoyed, 0 did not enjoy, 27.6% no opinion

2023:

58.8% enjoyed, 14.7% did not enjoy, 11.8% no opinion

Could the change mean things have gotten worse? Or just that we've only done this twice, and people are more involved now.

Nuc Sale 2024:

Whether or not we buy nucs for next year needs to be decided soon. James is content to wait until Jan 2024 before selling us the nucs.
